## OLD BUSINESS

#### Street Paving Update

• Work completed. We have a 1 year warranty on blacktop road paving

#### Sidewalk & Curbs Update

- Work completed. Each homeowner has a 20 year warranty on their sidewalks and curbs based on the home's initial settlement date. The warranty can be voided by using de-icers that result in spauling (chipping or flaking of concrete)
- Sidewalk caulking will be done in Spring

#### Pool Update

- Pool was drained, resurfaced, and caulked in September
- Two concrete slabs around Pool (and one in front of Fitness Center) were replaced

#### Ocean Atlantic Transition Update

• Final transition agreement nearly completed; a few small issues remain

#### Natural Gas Update

• Per Chesapeake, all homes have been converted to natural gas as of 1/6/17

#### Landscaping Update

- Considering adding plantings around mailbox cluster and in front of new fence installed at intersection of Pilotboat & Zwaanendael
- Soliciting bids to treat the trees along bike trail for invasive vines this Spring
- Solitude (who will be replacing Envirotech as our pond management company) have removed the pond pumps for cleaning

#### Property Management Company Update

- Signature Property Management has replaced Right Property Management effective 1/1/17
- Stuart Galkin introduced himself and gave a brief background on Signature

## Fitness Center Update

• New contracts have been signed for (1) equipment maintenance, and (2) cleaning

# Access System Update

- Current system can no longer add fobs for new residents/vendors to our pool/fitness center areas
- Current system is too old to repair; Advantech won bid to replace system

# Financial Update

• Pending final December expenditures, we should be within \$5,000 (1.25%) of 2016 Budget
